

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to clavijosocceracademy.com, and Nino Solutions LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Nino Solutions LLC include clavijosocceracademy.com and CSA. The CSA website is a ecommerce site. By using the CSA website, you consent to the data practices described in this statement.

## Collection of your Personal Information

In order to better provide you with products and services offered, CSA may collect personally identifiable information, such as your:

- First and Last Name
- E-mail Address
- Phone Number

CSA may also collect anonymous demographic information, which is not unique to you, such as your:

- Age
- Gender

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. CSA may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on CSA or the site; (b) protect and defend the rights or property of CSA; and/or (c) act under exigent circumstances to protect the personal safety of users of CSA, or the public.

### **Tracking User Behavior**

CSA may keep track of the websites and pages our users visit within CSA, in order to determine what CSA services are the most popular. This data is used to deliver customized content and advertising within CSA to customers whose behavior indicates that they are interested in a particular subject area.

### **Automatically Collected Information**

Information about your computer hardware and software may be automatically collected by CSA. - SSL Protocol

- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity;
- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

### **Children Under Thirteen**
